Note: As per Govt. Instructions Govt. letter No. 22/55/81-3 GIII dated: 15.03.1983 as amended letter No. 22/4/84-3GS-III dated: 08.03.1984 where some period experience is prescribed as an essential qualification for direct recruitment to a post, and sufficient number of persons with the prescribed experience are not available for Scheduled Caste, Backward Classes, Ex-servicemen and Handicapped, the experience, qualification shall be relaxable to the extent to 50%. The qualification regarding experience is relaxable at the discretion of selection committee provided that reasons are recorded in writing to that effect.

Terms & Conditions for Assistant Professor:-

- Age: - (As on before the last date of submission of applications i.e 09.03.20) - Not less than 25 or not more than 55 yrs.
- These posts will be governed by Rules & Regulations of Pt. B.D. Sharma University of Health Sciences, Rohtak Act 2008/Haryana Medical Education Service (HMES) Rules, 1988 (amended from time to time)/HMES (Amendment) Rules 2007.

General Terms & conditions:-

1. Date of interview schedule shall be displayed on the website www.bpsgmckhanpur.ac.in. **No separate letter will be sent by post, hence the applicants are advised to visit the college website regularly.**
2. Original documents along with one set of self attested photocopies to be produced at the time of interview:-
 - a) 10th Class Certificate for proof of date of Birth.
 - b) Certificate for proof of reservation category, if applicable
 - c) MBBS, MD/MS, Post Graduates degrees.
 - d) Attempt Certificate during various degree programs.
 - e) MCI/DCI or State Medical council Registration for MBBS and subsequent qualification as applicable.
 - f) Certificate of additional qualification where applicable.
 - g) Experience Certificate
 - h) Photocopies of the research publications along with copy of proof of indexing status of the journal in which the research article is published.
 - i) Certificate of presentation of research article at a conference.
 - j) Sports certificate for prize or position in an international/national/inter University sports or athletic meet.
 - k) College colour Certificate for Sports.
 - l) Any other Certificate.
3. Benefits of age relaxation: - The upper age limit prescribed for appointment to any service or posts shall be relaxed in favour of ex-serviceman to the extent of his military service added by three years provided-
 - (a) He has rendered continuous military service for a period of not less than six months before his release; and
 - (b) He was released otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.
4. Applicant must also bring all the original documents listed on serial number 1 of the general terms and conditions and one set of self attested photocopies of the said documents. All these should be submitted at the time of interview.

Details of the desirable Research Work/Publications(in annotated form) indicating index/non index along with attested copies and best five research works along with citations supported by relevant documents must also be furnished. Any other relevant outstanding National/international achievements in the profession supported by documents, if any, must also be supplied.
6. Numbers of posts is liable to increase or decrease, including complete withdrawal without assigning any reason.
7. The candidates already in service of any State/ Central Govt. / Semi Govt. / Corporation or Autonomous Body/Private Institute service should send their respective Head of Institute or 'No Objection Certificate' may be submitted at the time of interview failing which the applicant will not be allowed/considered for interview; NOC may not be older than three months. Further, the candidature of applicants who have resigned from their posts will be considered if their resignation has been accepted from their employer.
8. For the posts of Assistant Professor, only the experience gained in a Medical College which is permitted/recognized by the MCI will be counted towards teaching experience.
9. In Case any applicant belonging to Scheduled Casts or Backward Classes or any other reserved category applies against General Category post, he/she must fulfil the conditions of eligibility regarding age/application fee, etc. as are meant for General Category candidates (as per Govt. instruction)
10. In case any discrepancy is detected in the document submitted by the applicant or in the process of selection at any stage even after the issue of appointment order, the University reserves the right to modify/withdraw/cancel any communication made to the applicants.
11. The prescribed qualification, experience and age limit etc. shall be reckoned as on the closing date of submission of applications i.e 09.03.2020
