**TO CONSIDER AND APPROVE THE AMENDMENT IN THE COMPOSITION OF P.G. BOARD OF STUDIES**

Under clause 2(1)(a) of statute 39 of the schedule of University Act. & Statute 2008, there is provision that the chairman of PG Board of Studies from amongst the Senior Professors in the subject constituting the board on the basis of seniority & rotation is appointed. It has been observed that in various deptts. one post of Sr. Prof. is sanctioned and the same Sr. Professor is being appointed as Chairman in PG Board of Studies time & again, whereas in some deptts, there is no Sr. Prof. working at present. It is proposed that senior most Professor may also be appointed as Chairman in the PG Board of Studies in the subject on the basis of seniority & rotation.

The matter was placed before Academic Council in its meeting held on 25.02.2016. The Academic Council considered the agenda and resolved that where there is no Sr. Professor, senior most Professor be appointed as Chairman of the PGBOS in that subject in PGIMS and PGIDS on the basis of seniority by rotation. The Academic Council further recommended the same to the Executive Council for approval.

**The Executive Council resolved that the recommendations of the Academic Council be approved and Statute-39 be amended after obtaining the assent of the Hon'ble Chancellor.**

**TO CONSIDER AND APPROVE THE REVISED FEE STRUCTURE FOR MBBS AND BDS COURSES FROM ACADEMIC SESSION 2016-17**

Fee structure was revised for admission to MBBS 1<sup>st</sup> Prof. from the session 2013-14 vide office order bearing endst.No.ST-I/13/6361-66 dated 19.7.13 for a period of 3 years. Now, there is need for review the same as process of admission for the session 2016-17 is going to be started very soon and hence two committees were constituted. Both the committees have recommended that on the basis of previous increase in fee structure during the year 2013, the fee structure may be increased by 25% (approximately). The electricity charges may be increased by 50%. Accordingly revised fee structure for admission to MBBS & BDS Course from Academic session 2016-17 was proposed as under:-

- The above revised rates will be charged from all new admitted students excluding old students who will continue paying the existing tuition fees. However, the revised hostel charges will be applicable to all students both (old and new).
- In connection with revision rates of university charges, matter may be reviewed by Dean Academic Affairs, UHS Rohtak.
- It is proposed to enhance the fine charges applicable as under:-

#### Fine:

Delay in Payment of fee by 1 week:	Rs.500/-
Delay in payment of fee by 2 weeks:	Rs.1000/-
Delay in payment of fee by 1 month:	Rs.2000/-

The agenda was placed before Academic Council in its meeting held on 25.02.2016. The Academic Council considered the agenda with the following amendment:-

*"That the word 'MBBS Course' be replaced with the words 'MBBS and BDS Courses' in the heading of the table"*

After incorporating the proposed amendment, the same was placed before the Executive Council for consideration and approval.

**The Executive Council resolved that the fee structure as well as hostel fee as recommended by the Academic Council be approved with the following amendments:-**

- Electricity and water charges Rs.9000/- be applicable to all the batches for all courses.
- If a student is expelled from the hostel for few months no hostel charges shall be refunded. However, if a student is expelled permanently from the hostel then the hostel and other charges shall not be levied for the subsequent years.
